
ATTENTION TRAINERS: DO NOT SHIP HORSES TO STABLE AT WILL ROGERS DOWNS THAT ARE NOT IN-TODAY OR APPROVED BY THE RACING SECRETARY FOR STALLS. ALL HORSES MUST VACATE THE WILL ROGERS DOWNS BACKSIDE BY TUESDAY, MAY 27, AT 5:00PM. Stall applications for Fair Meadows Tulsa are available in the racing office or online at exposquare.com/stallapplication.

Weather permitting, morning training hours are 7:00-11:00am, break from 9:00-9:30am, dark Thursday. Gates will be set from 8:00-10:30am, no gates Friday. There is no training on the training track unless the main track is closed and EMTs are present. Please consider tracking two-year-olds right before the break or after 10:00am when traffic is lighter. Thank you for your cooperation.

ALL THOROUGHBREDS MUST BE REGISTERED WITH HISA BY THE TIME THEY RECORD THEIR FIRST OFFICIAL WORKOUT. TRAINERS CAN CHECK THIS ON THE WORKTAB AND MAY REPORT ANY ERRORS OR OMISSIONS TO THE CLOCKER WITHIN 24 HOURS, AFTER WHICH NO SUCH CLAIMS WILL BE CONSIDERED. Thank you.

UPDATED: phone in to the post-position draw by calling (945) 468-5504 and entering access code 658 210 233 when prompted. Please mute cell phones to eliminate background noise until asked for representation.

ATTENTION TRAINERS: Please check the past performances (available in the racing office) on entry days to ensure that your horses have been entered properly. Corrections to ownership, equipment, medication, and weights can be made before going final.

Mandatory race-day veterinary inspections will begin at 7:00am at Barn D. Trainers with assigned stalls must have horses in place at that time. In-today horses hauling in must be on the grounds by 10:00am and in the appropriately assigned location for inspection. Trainers that plan to ship into a barn other than the haul-in barns must plan with the stall superintendent on the day of entry. Inspected horses must remain on the grounds until after the race.

To obtain an official workout time at WRD, it is mandatory to complete and submit workout cards. Please pick up workout cards ahead of time from the racing office, clocker, or gap attendant. WORK OFFS FOR THE TRACK VETERINARIAN WILL TAKE PLACE ON RACE DAYS AND MUST BE SCHEDULED ONE WEEK IN ADVANCE. Thank you for your cooperation.

Horsemen wishing to haul in for workouts on race days or arrive with horses that are not "In-Today" are to contact (918) 633-2463 in advance for accommodations or stall space. Trainers must obtain approval before occupying the haul-in barns with horses that are not designated as "In-Today". Trainers should be prepared to work-and-go. Thank you for your cooperation.

PADDOCK TARDINESS AFFECTS EVERYONE AND IS UNACCEPTABLE. PLEASE PREPARE RESPONSIBLY AND ARRIVE TO SADDLE PROMPTLY. TRAINERS ARE TO TAKE RESPONSIBILITY FOR THE SADDLING OF THEIR OWN HORSES, OR REPORT TO THE STEWARDS IN THE EVENT AN ASSISTANT OR PROXY IS TO BE USED.

Pony horses may enter the saddling paddock only with prior approval from the paddock judge and are not permitted inside the Winners' Circle. Thank you for your cooperation.

Vehicles on the backstretch must always yield to horses - no exceptions. There is no parking on the roadway between barns on race days. Also, help us keep the backside roads intact by minding the 15 MPH speed limit. Thank you for your cooperation.

PLEASE BE REMINDED THAT ALL WORKOUT REQUIREMENTS MUST BE MET PRIOR TO ENTRY.

ATTENTION TRAINERS: THE TRACK VETERINARIAN IS ASKING TRAINERS TO NOTIFY HER DIRECTLY ONCE 150-DAY LAYOFF REPORTS HAVE BEEN SUBMITTED INTO THE HISA PORTAL. REPORTS ARE GOOD FOR 90 DAYS. TRAINERS SHOULD PLAN AHEAD AND SUBMIT THESE REPORTS ONCE SAID HORSES START BREEZING. Thank you for your cooperation.
